## Terms and Conditions

### CONDITIONS

---

“Resident” refers to the successful applicant.

“Studio” refers to the Ed Tweddell Studio at Central Studios Inc.

“Residency” refers to the Ed Tweddell Studio Residency

1. The Ed Tweddell Studio Residency is hosted by Central Studios Inc, 78 King William Street, Kent Town, South Australia 5067. The Residency is funded by Department of Premier and Cabinet through Arts South Australia.
2. The Residency is open to all artists residing in South Australia.
3. The Residency is for a period of six months and provides the Resident with a private, lockable studio of 17.5m<sup>2</sup>, with 24 hour access.
4. The Resident shall use the Studio to work on the project as described in their application’s project statement.
5. The Resident shall not use the Studio for commercial gain beyond any outlined in their project statement.
6. The Resident shall have no commitment which will inhibit their use of the Studio for the period of the Residency. This includes other residencies.
7. The Resident agrees that they shall use the Studio under the conditions which apply to Central Studios artists.
8. The Resident is encouraged and welcome to participate in any studio activities that may occur during the Residency. For example, open studios and social events.

9. The Resident will discuss the work they produced during the Residency in an informal presentation to Central Studio members in the final week of the Residency.
10. The Resident shall provide an acquittal report to Central Studios Inc within 28 days of the completion of their residency. The report shall describe what was achieved during the Residency and include links to any exhibitions or media resulting from the Residency.

## **SUBMITTING APPLICATIONS**

---

The Ed Tweddell Studio Residency is project based. Applications are assessed on a statement describing a project the applying artist intends to work on during the Residency, images of the applicants work, and their CV.

Applicants must be residents of South Australia.

The applicant must include the following support documents in their application:

1. A Statement no longer than 500 words describing their project and how they intend to use the Ed Tweddell Studio.
2. Up to 10 images of their work. A PDF portfolio is preferable. If images are submitted individually, they must be accompanied by a list detailing title, media, size, and year.
3. A CV.
4. A link to their website or social media.

Files can be no larger than 10MB

All files uploaded must use the following naming convention:

- surname\_firstname\_statement
- surname\_firstname\_titleexample (for images), surname\_lastname\_imagelist (for image details list)
- surname\_firstname\_portfolio (for a compiled portfolio)
- surname\_firstname\_cv
